As from **1<sup>st</sup> January 2010**, OTHM is pleased to announce a reviewed fee structure (based on the World-Bank ratings of countries).

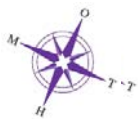
**The World Bank** has allocated countries into three separate regions (Region 1, Region 2 and Region 3). The United Kingdom falls into Region 1 along with other Financially Developed countries – (normal OTHM fees apply for all Region 1 Countries).

OTHM students who are registered and studying overseas need to check **The World Bank** list for the appropriate OTHM fee (see chart below).
